3. The Bidder should sign and affix his/ her firm's stamp on each page of the Auction Notice and all its Annexure as the acceptance of the offer. NO PAGE SHOULD BE REMOVED/DETACHED FROM THIS NOTICE INVITING AUCTION.

4. Earnest Money:

The amount of Token Earnest Money in the shape of Bank Draft of any nationalised/scheduled bank drawn in favour of the "West Bengal Agro Industries Corporation Ltd." payable at Kolkata against the work shall be deposited with Account Section of WBAIC Ltd. at Registered Office before the deadline.

i. Refund of Earnest Money deposit: -

The Earnest Money of all the unsuccessful bidders will be refunded by the Project Manager within 30 days from the date of finalization of the Auction on receipt of application & Original Money Receipt from the bidders.

5. Acceptance of Bid:

- i. Bid will be evaluated on Total Bid Value.
- ii. The Highest Bidder shall quote Highest Rate for all the Items with compare to other bidders.
- iii. Highest valid rate should normally be accepted. However, the Tender Accepting Authority does not bind himself to do so and reserves the right to reject any or all the Auctions, for valid reasons.
- iv. In case of tie, sealed bids shall be invited only from those bidders offering same highest rate.
- v. In case, each rate of most of the items obtained from Highest Bidder found lower than other bidders. Then, the sealed bids shall be invited only from those bidders.
- vi. In case, the Highest bid/offer is less than the Base Value, the Highest Bid/offer will not be accepted, and his/her Auction will stand Cancelled.

6. Rejection of Bid:

Tender Inviting Authority reserves the right to accept or reject any/or all bid and to cancel the Bidding processes and reject all Bids at any time prior to the award of contract without thereby/incurring any liabilities to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the ground for such action.

7. During scrutiny if it comes to the notice of the Tender Inviting Authority that the credential or any other papers of any bidders is incorrect/Manufactured/fabricated that bidder will not be allowed to participate in the Auction and that application will be out rightly rejected without any prejudice with forfeiture of earnest money forthwith.

8. Seller's Right to vary quantities at time of award:

The Corporation reserve the right to increase or decrease the quantity of Auctioned items at the time of award of contract without any change in rate or other terms & conditions.

9. <u>Issue of Lifting Order:</u>

Lifting order will be issued to the highest bidder/s only.

10. Lifting of Materials:

Lifting of Materials will have to be completed within 07 (Seven) Days from the date of be reckoned from as mentioned in the lifting order. No extension of time will be granted for lifting of materials. The Bidder shall lift the materials in presence of Charge Officer. The Total Quantity shall be counted at the time of Lifting of Materials.

The Bidder shall sign and confirm the quantity of the "List of Materials" in presence of Charge Officer before removing the Scrap Items from the premises.

In the event of non-lifting of any materials by the bidder within the specified time, the materials remain to be lifted will be the sole property of the Corporation and the Earnest Money will be forfeited and no refund is admissible in this respect.

11. Deposition of Bid Amount:

The Total Sale/Bid Value will be calculated on basis of quantity of the items listed by the Charge Officer. The Highest Bidder will have to pay the total bid amount, in full, within 07 (Seven) days from the Date of Lifting the Scrap Items from the site, failing which EMD will be forfeited and no correspondence in this regard will be entertained.

The Full Payment is to be made by a Bank Draft drawn in favour of "West Bengal Agro Industries Corporation Ltd." payable at Kolkata, purchased from any schedule bank.

No extension of time in this respect will be granted.

INSTRUCTION TO BIDDERS

- 1. The actionable material shall be disposed of in "as is where is basis" basis. It is expressly understood that the bidder is fully satisfied himself regarding the quality, quantity & condition of actionable material before bidding. - c) The Bidder has to quote rate in all the items. Else, the Bid will be rejected.
- d) The bidder should quote the price in the Price-Bid excluding the taxes and duties.
- e) Quantities mentioned in the Annexure A are indicative. Quantities may vary at the time of Lifting of Materials.

f) Taxes:

- GST or any other taxes applicable will be charged extra.
